Safety

Veterinarians use a host of powerful medications in the practice of medicine. When these medications are misused, they represent a danger to patients, staff, and the practice itself.

Profitability

Are you charging appropriately for the dispensing of controlled substances?

In most veterinary practices, it takes approximately 1.5 hours daily to manage controlled substances using manual processes. Given the risks and administration time required to dispense controlled substances, does it make sense to charge the same fees for a narcotic as an antibiotic?

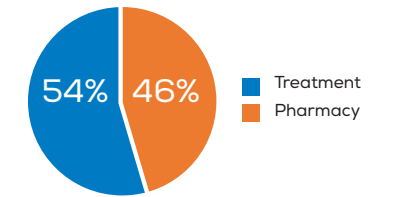

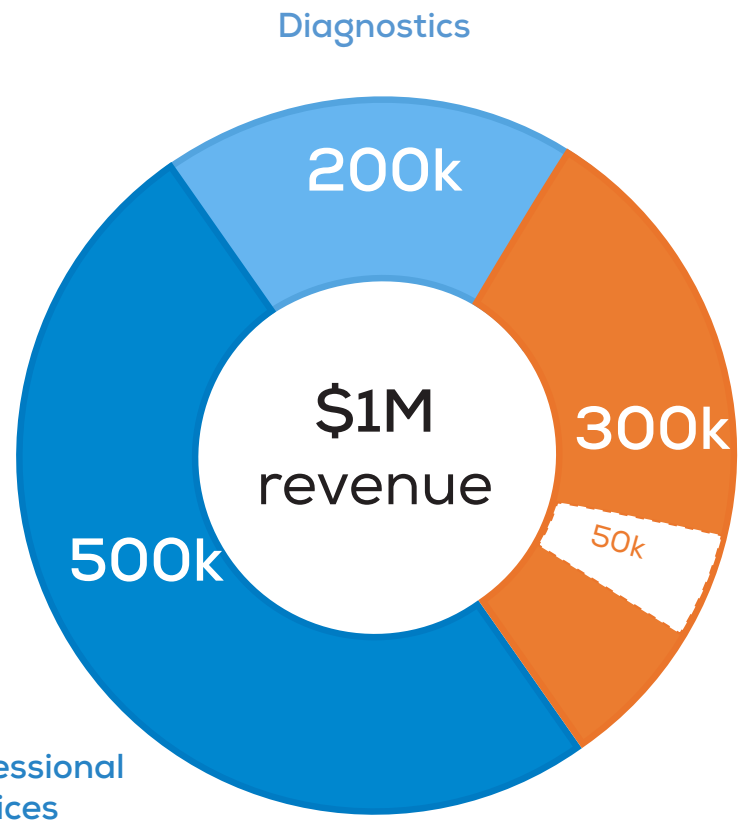
